INDUSTRY

01 Excellence in Industrial All - Round Performance - Large Industries

Instituted by Spectra Shares & Scripts Pvt. Ltd.,

It also includes expansion of the business, and diversification, including joint ventures.

02 Excellence in Industrial All-Round Performance - Small Medium Enterprises

Instituted by VBC Industries Limited*

Recognizes companies with an annual turnover of up to Rs. 250 crores and business excellence using best practices in all areas of industrial activity, ushering in the developmental growth of the company's products, services, technologies, processes, management practices, research & development, social & labor welfare initiatives, and ancillary development. It also includes expansion of the business, and diversification, including joint ventures.

Recognizes enterprises with a strong market presence and proactive efforts to develop new markets or products. These enterprises should demonstrate global competitiveness through quality, timely delivery, and competitive export pricing.

05 Excellence in Export Performance - Small Medium Enterprises

Instituted by Ch. Venkateshwar Rao*

Recognizes companies with an annual turnover of up to Rs. 250 crores
Recognizes enterprises with a strong market presence and proactive efforts to develop new markets or products. These enterprises should demonstrate global competitiveness through quality, timely delivery, and competitive export pricing.

06 Excellence in CSR

*Sri Ayyadevara Venkat Radhakrishna Memorial Award
Instituted by Srinivas Ayyadevara, C.A., Hyderabad*

Recognizes corporate endeavors targeting India's marginalized and remote regions, also focusing on innovative ideas that address environmental or social issues. Evaluation criteria include the social impact, community outreach and sustainability of CSR spending.

07 Excellence in Aerospace & Defence Industry

Instituted by Gowra Srinivas, Gowra Ventures Pvt Ltd.

Recognizes enterprises with the potential to impact the practice of aerospace engineering and defense along with scientific achievements and breakthroughs. They should also have scalable projects with potential import substitution in India's Aerospace/Defense sector.

08 Excellence in Pharma

Instituted by Suven Trust

This award recognizes enterprises that exemplify excellence in innovation within the pharmaceutical industry, showcasing exceptional quality, merit, and potential impact along with their diversified activities that have led to the creation of new knowledge, management strategies, or practices. Additionally, nominees should have a record of international spread or a sustainable plan for global competitiveness.

09 Excellence in ESG Performance - Large Industries

Instituted by Sigachi Industries Ltd

This award recognizes organizations that have demonstrated leadership in integrating Environmental, Social, and Governance (ESG) criteria into their investment decisions with evidence of its impact. Nominees should showcase innovative project financing, including work on environmental stewardship, ESG values, sustaining natural resources, and reducing pollution and waste.

Eligible enterprises should showcase a positive impact on revenue through their marketing expenditure. Additionally, they should exhibit a diverse and effective range of marketing channels.

12 Excellence in Product Innovation - Large Industries

Instituted by MRF Ltd, Sadashivpet.

This award recognizes enterprises that have made significant investments in innovation for their products and services, resulting in a positive impact. These enterprises are characterized by adopting new thinking, procedures, and technologies that contribute to immediate and long-term revenue generation.

13 Excellence in Product Innovation - Small Medium Enterprises

15 | Excellence in Research & Development - Large Industries

Instituted by Elico Ltd

This award recognizes enterprises that have demonstrated excellence in research and innovation by actively engaging in funded research projects and collaborations with industry. These enterprises should have made significant contributions through high-impact publications, a strong patent portfolio, and successful new product or service launches, which have had a notable impact on the market

16 | Excellence in Start-up

Instituted by State Bank of India (SBI)

This award recognizes startups that have grown significantly with their innovative idea or product & execution. Nominees should demonstrate the strength and stability of their business, highlighting their ability to sustain and grow their operations, and showcasing a clear vision for future development. Nominees should also demonstrate effective financial controls to monitor progress and control cash flow.

17 | Excellence in Digital Transformation

Instituted by Bharat Cloud

This award recognizes organizations that have demonstrated increased operational efficiency through digital adoption, by incorporating new software to adapt to market changes and increasing productivity and also enhancing customer experience.

Nominees should demonstrate a clear positive social or environmental impact resulting from their initiatives along with a sustainability plan.

- STEP 4: After filling out the Questionnaire – Save & Submit it.
- STEP 5: Complete Online payment using the payment gateway

GUIDELINES & CONDITIONS

FTCCI Excellence Awards is open to all in the state of Telangana

- ✓ Individuals, partnership, LLP, proprietary concerns, companies, research bodies, industry/trade associations, and industrial organizations engaged in applied research functioning or operating in the State of Telangana are eligible for the FTCCI Excellence Award.
- ✓ By participating in the Awards, the applicant agrees to abide by the guidelines and conditions laid out by the Award Committee.
- ✓ The nomination will be considered accepted only upon receipt of the application fee. The application fee is non-refundable.
- ✓ Selection for the award is subject to the fulfillment of the prescribed criteria, guidelines, and conditions
- ✓ No applicant will be eligible for the same award within two years of receiving the same. However, if a business or organization has more than one company and the companies are autonomous/separate legal entity and produce or provide a different product or service, can apply for the same award in the succeeding year.
- ✓ The Awards Committee may advise entries to move to the more appropriate category.
- ✓ To prevent any conflict of interest, all Managing Committee members, Past Presidents, active members, and sponsors participating in the awards are prohibited from being involved, directly or indirectly, in the administration or judging process.
- ✓ In the case of a company with nationwide operations, only the performance of the unit in Telangana will be considered.
- ✓ The Jury of Awards Committee of the FTCCI will decide the winning entries for the various categories. The committee may at its discretion co-opt experts/specialists to assist in the decision making.
- ✓ The decision of the jury will be final and binding.
