I am to inform that the Commissioner of Labour, Andhra Pradesh, Hyderabad, is the Competent Authority to declare the average rise in the State Consumer Price Index numbers for Industrial Workers as well as Agricultural Workers twice in a year i.e. on 1<sup>st</sup> April, and 1<sup>st</sup> October of every year in various Scheduled employments covered under the Minimum Wages Act, 1948 by taking into account the average rise in the State Consumer Price Index numbers for Industrial Workers as well as Agricultural Workers for the half year ending December and June respectively. The Commissioner of Labour, Andhra Pradesh, Hyderabad, and the Competent Authority under the Minimum Wages Act, 1948, has declared the average State Industrial Workers Consumer Price Index Numbers for the first half year ending December, 2014, as 1133 points (Base year 1982=100 series) for Industrial Workers under Part-I and 868 points (Base year 1986=100 series) for Agricultural Workers under Part-II which are applicable for the period from 01.04.2015 to 30.09.2015 in various Scheduled Employments notified under the Minimum Wages Act, 1948, for the purpose of calculation of Variable Dearness Allowance.
