The Provisions of Tax Deducted at Source (TDS) and Tax Collected at Source (TCS) under Income Tax are regularly amended, making it complex for a Deductor. Further the Return Filing Procedure adds to the complexity.

The **FINANCE ACT 2021** has introduced two new changes in rules relating to **Tax deducted at source (TDS)** or **Tax collected at source (TCS)**.

Until now, a higher TDS rate was deducted only for those who didn't have PAN. But from July 1st, 2021 a higher rate would be deducted if you have not filed IT returns in the last two previous years under the newly inserted Section 206AB (for TDS) and 206CCA (for TCS) in the Income-Tax Act, 1961.

Need has been felt to deliberate on key issues on the various provisions and new developments relating to TDS and TCS and for better compliance this program has arranged.
