**GREATER HYDERABAD MUNICIPAL CORPORATION****Press Note**

In view of the Bye-law No.3 (I) (b) of G.O. Ms.No.288 MA&UD, dated: 04-07-1973 all the traders have to get their license renewed before completion of present validity period and the current Trade License expires on 31st December 2022.

As per G.O.Rt.No.459, dated: 22.06.2017 of MA&UD on implementation of Ease of Doing Business Norms (EODB), Trade License is renewed automatically on payment of renewal fee. Trade License Certificate would be valid for the period January 2023 to December 2023.

As per the Resolution No. 19, dated: 27.07.2017 "if a trade is identified to be carried on without license, 100% penalty will be imposed on the trader at the time of identification followed by the fine @ 10% every month until the trader obtains trade license".

All the traders in GHMC are requested to avail opportunity to obtain trade license by making online payment for obtaining Provisional Trade License Certificate immediately and renew their license between by 31st January 2023 in any Mee-Seva Centers/ CSC in GHMC Head office & Circle offices and those traders who have not obtained trade license so far are requested to apply for fresh trade license online or approach any Mee-Seva Centers.
