Subject: Shelf life of Fortified Rice and Fortified Rice Kernel-reg.

\*\*\*

This is in reference to the shelf life of Fortified Rice (FR) and Fortified Rice Kernel (FRK). FCI has brought to the notice of FSSAI that in some cases Certificate of analysis (CoA) issued by RK manufacturers contains expiry date. It has been further informed by FCI that the quantum of procurement of fortified rice is much more than that of annual requirement of NFSA/OWS schemes, therefore a bulk quantity remain in storage beyond one year period.

2. Further, FCI has intimated that a study to determine shelf life of FR and FRK is under process and it may take more than 2 years to complete.
3. In view of the above, in order to avoid any ambiguity w.r.t shelf life of FR and FRK, all the FSSAI notified laboratories are advised not to mention date of expiry or any information related to shelf life of the FR and FRK until any further discretions from the Food Authority.
4. This is for information and necessary action by the concerned stakeholders.

### NOTIFICATION

In exercise of the powers conferred by clause (a) of section 2 of the Industrial Employment (Standing Orders) Act, 1946 (Act No.20 of 1946) (hereinafter referred to as the said Act”) read with Rule 11 of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Rules, 2013, the Government of Telangana being an appropriate Government appoints eight (8) Labour Courts & Industrial Tribunals in the Telangana State constituted under section 7 of the Industrial Disputes Act. 1947 mentioned in column (2) of the schedule appended hereto, as the Appellate Authority in their respective jurisdictions, to exercise the functions of an Appellate Authority under the said Act in respect of the Industrial Establishments in relation to which the State government is the appropriate authority for preferring appeals in the cases of Sexual Harassment of Women at Workplace.
