GOVERNMENT OF TELANGANA ABSTRACT

RULES Environment, Forest, Science & Technology Department Amendment to the Telangana Forest Produce Transit Rules, 1970 Notification - Orders Issued.

ENVIRONMENT, FORESTS, SCIENCE & TECHNOLOGY (FOR.I) DEPARTMENT

G.O.Ms.No. 105

Dated: 07-10-2023 Read the following:

- Telangana Forest Produce Transit Rules, 1970 issued in G.O.Ms.356, Environment, Forest, Science & Technology Department, dated: 04.03.1970 (earlier issued in Food & Agricultural Department) published in AP Gazette RS to Pt II, dt.30.04.1970.
- From the PCCF (HoFF), TS, Hyderabad, Rc.No.1109/2015/Prod.2, dated:03.02.2023. 2.
- From the PCCF (HoFF), TS, Hyderabad, Rc.No.1109/2015/Prod.2, dated:02.09.2023

ORDER:

Government, with the objective to promote seamless movement of Forest Produce across States and Ease of Doing Business, has proposed to issue Transit permits through an online system under the National Transit Permit System (NTPS). In accordance with this proposed initiative, it is envisioned to amend the relevant Rules, as follows, as a pre-requisite to enable implementation of NTPS.

Accordingly, the following notification shall be published in an extraordinary issue of Telangana Gazette, dated: 07.10.2023.

NOTIFICATION

In exercise of the powers conferred under section 29 read with section 68 of the Telangana Forest Act, 1967 (Act 1 of 1967), Government hereby makes the following amendments to the Telangana Forest Produce Transit Rules, 1970, subsequently as amended from time to time, issued in G.O.Ms.356, Environment, Forest, Science & Technology Department dated:04.03.1970:

AMENDMENT

In the Telangana Forest Produce Transit Rules, 1970,-

- In Rule 2, after Clause (4), the following Clauses shall be added:
- "Transit Permit in Form-II (e Form)" means it is a permit which shall be issued through www.ntps.nic.in or in any web site notified by the Government of India / Government of Telangana from time to time for transportation of forest produce throughout the Country including in the State of Telangana".
- "No Objection Certificate" means it is a certificate which shall be issued through www.ntps.nic.in or in any web site notified by the Government of India / Government of Telangana from time to time for transportation of exempted species as listed in Schedule-II of this Rules outside the State of Telangana".

- In Rule 5,-
- for sub-rule (1), the following shall be substituted:
 - "(1). The District Forest Officer or an Officer or person duly authorized by him in this behalf shall, subject to the provisions of these rules, issue a permit in Form-II manually or Form-II (e Form) online through National Transit Pass System in respect of forest produce. The District Forest Officer may refuse to issue such permits, if he has any doubt either of ownership or the existence of forest produce itself and, may withhold the issue of transit permits till it is proved to his satisfaction that the forest produce that exists lawfully belongs to the applicant".
- for sub-rule (5), the following shall be substituted:
 - "(5). For the supply of Form-II and Form II (e) Form), Permits in triplicate either manually or under National Transit Pass System through online respectively, the following shall be charged per Permit and subsequently as modified by the Government of Telangana from time to time:

Item	Charge per permit
Major Minerals / Minor Mineral / Granite	Rs.30.00/Tonne/Cmt.
Timber	Rs.10.00 per Cmt.
Fuel Wood	Rs.5.00 per Cmt.
Bamboo & other Forest Produce	Rs.100.00 per Lorry / Four Wheeler & above and Rs.50.00 per Cart.
From Intermediate Depot, including GTD to Destination for all Forest Produce.	Rs.100.00 per Permit.

- (c) for sub-rule (9), the following shall be substituted:
 - "(9). In municipalities and Municipal Corporation areas where the saw mill owner, depot owner dispose Forest produce except round timber within the local limits of Municipalities or Municipal Corporations, they should issue delivery Challan in Form-IV along with the forest produce sold. Form-IV can be got printed by the saw mill owners or depot owners themselves and use them after informing Book No. and No. of leaves in each book to concerned Forest Range Officers and District Forest Officers by Registered Post with Acknowledgement due or they can opt for online transit permit in Form-II (e Form) under National Transit Pass System".
- For Rule 15, the following shall be substituted:
 - "15. The Officer-in-charge of the check post or barrier shall, after satisfying himself that the forest produce is genuinely covered as per rules by the permit or No Objection Certificate (NoC) for exempted species issued under National Transit Pass System by the State of Origin and that in case of timber such timber bears the Government transit mark, endorse on the said permit, the fact of checking and indicate the date and time of check before allowing the vehicle to proceed further as expeditiously as possible".
- For the words "Divisional Forest Officer" wherever they occurs the words "District Forest Officer" shall be substituted. 4.
- Under Rule 5, the 'FORM I' shall be deleted. 5.
- 6. Under Rule 5, the 'FORM II (e - Form)' shall be added.
- 7. Under Rule 16, the "No objection Certificate" shall be added.

S.O.(E) In exercise of powers conferred by Section 3 read with section 5 of the Foreign Trade (Development & Regulation) Act, 1992 (No.22 of 1992), as amended, read with Para 1.02 and 2.01 of the Foreign Trade Policy, 2023 and in accordance with the provision contained in Para 2 (iv) of Notification No.20/2023 dt. 20.07.2023, export of following quantity of Non-Basmati White Rice (under HS code 1006 30 90) to Nepal, Cameroon, Cote d' lvore, Republic of Guinea, Malaysia, Philippines and Seychelles is permitted through National Cooperative Exports Limited (NCEL).
