ORDER:

NOTIFICATION

In exercise of the powers conferred by sub-sections (1) & (3) of section 3 of the Telangana Essential Services Maintenance Act, 1971 (Act 20 of 1971), Government of Telangana hereby prohibits strikes in all the services under the Transmission Corporation of Telangana Limited and Three Distribution Companies (i.e TGNPDCL, TGSPDCL & TGRPDCL) for a further period of six (6) months with effect from 25.08.2026 to 24.02.2027.

3. The C&MD, TGTRANSCO, Hyderabad shall take further necessary action in the matter accordingly.

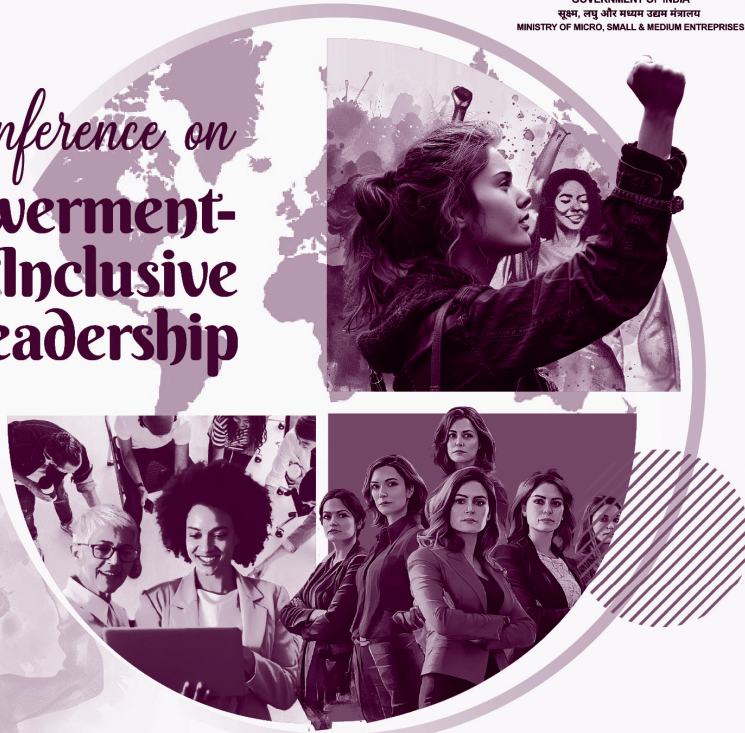

3. The Internal Complaints Committee shall receive complaints regarding sexual harassment of women employees in workplace and enquire in the matter and prepare a detailed enquiry report.
4. The said committee shall furnish the detailed reports on sexual harassment of working women in the Department to the Secretary to Government for initiating necessary disciplinary action as per rules in force.
5. The Committee shall follow the instructions/guidelines issued by the Government from time to time in the matter.

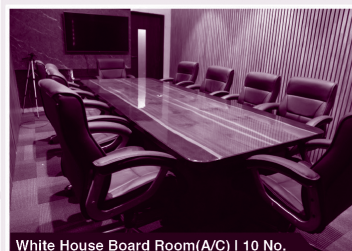

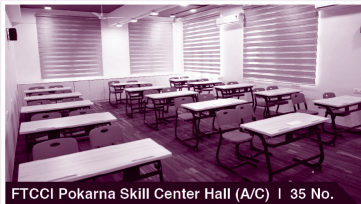
