- ▶ Made efforts to stop closure of Export Inspection Agency (EIA) sub office at Hyderabad.
- ▶ The Export Inspection Council has reversed its decision to close down the sub-office at Hyderabad. It provided major relief and has benefitted 400 plus registered exporters from the state of Telangana.
