Further, necessary entries in the demand registers may be made on rebate on Property Tax in case of payment received in full as stipulated above. The quantum of rebate made may be furnished to Head Office.

It is to inform that the Government vide Gazette Notification No 15 of 2013, dated 05-08-2013 Amended made to the GHMC Act – 1955 as under;

As per section 264(2) of GHMC Act 1955 of the following new sub-Section (3) shall be added namely.

"(3) A rebate of five percent of property tax shall be given in respect of assessments where property tax for the entire current financial year is paid before 30th April of the year notwithstanding the service of bill or Demand Notice."

The GHMC has introduced Property Tax Early Bird Scheme for the benefit of Property Tax Payers to make payment of property tax in April and avail 5% rebate given by the Government.

The Property Tax payers can now pay Property Tax from 1st April 2024 onwards as the Early Bird scheme is applicable for the Property Tax for the current financial year 2024-25 and not for arrears accumulating from previous years.

Therefore, all the Zonal Commissioners/Dy.Commissioners are hereby requested to take following measures:

a. Sensitize citizens/ tax payer association through SMS, Whats app group notifications, display boards at Citizen Service Centers, Mee-seva, etc., to avail Early Bird offer by paying current financial year 2023-24 Property Taxes at Citizen Service Centers, Bill Collectors, Mee-seva, Online, Mobile Apps etc. 8111/

- Display boards at all Circle offices, ward offices, Covernment offices, Banks and all possible areas.
- c. Sensitize through SHG groups about the opportunity, so as to have spread of mouth among the citizens of the town.

Bulk SMS shall be given to all tax payers by the Addl.Commissioner(II), GHMC time to time to avail Larly Bird offer with 5% rebate. A scrolling message may be displayed in GHMC website in the month of April appealing to the tax payers to avail Early Bird offer.
