ORDER:

In the G.O. 1st read above, Govt. have issued notification in consonance with Section 54 of the Electricity Act, 2003 and Regulation 43 and 30 of Central Electricity Authority (Measures relating to safety and electric Supply) Regulations, 2010, that "every electrical installation of voltage upto 650V shall be inspected , tested and shall be self- certified by the owner of the installation before commencement of supply or recommencement after shut down for six months and above for ensuring observance of safety measures specified under said regulations and such owner shall submit the report of self-certification in the Form-I or Form-II, as the case may be to the Electrical Inspector."

2. In the G.O. 2nd read above, Govt. have issued notification in consonance with Ease of Doing Business – Reform Action Plan-2017, Section 54 of the Electricity Act, 2003 and Regulation 43 and 30 of Central Electricity Authority (Measure relating Safety and Electric Supply) Regulations, 2010 that " under Ease of Doing Business , the functions of department for Certification of Electrical Installation of above 650V shall be online with effect from 01.07.2017 and the applications and documents submitted through online only be accepted and processed."

3. In the reference 3rd read above, the CEIG, Hyderabad has requested to issue a Government Order to submit and process the applications through online only for issuing Approval of DG sets of Capacity 10 KW and above irrespective of voltage under Regulation 32 of Central Electricity Authority (Measures relating to safety and electric Supply) Regulations, 2010 and issuing No Objection Certificate of new Cinema buildings and issuing electrical Certificate in the form D of new cinema buildings under Andhra Pradesh Cinemas (Regulations) Rules, 1970 (Telangana Adaptation).

4. In the circumstances reported by Chief Electrical Inspector to Government vide reference 3rd read above, and after careful examination of the matter, Government hereby decide that an application for the Approval of DG sets of Capacity 10 KW and above irrespective of voltage under Regulation 32 of Central Electricity Authority (Measures relating to safety and electric Supply) Regulations, 2010, an application for No Objection Certificate of new Cinema buildings and an application for Electrical Certificate in Form-D of new Cinema buildings under Andhra Pradesh Cinemas (Regulations) Rules, 1970 (Telangana Adaptation) shall be mandatorily submitted and processed online to facilitate the Ease of Doing Business.
